Should operators find errors, please do not send incorrect personal interpretations/amendments that may threaten safety, rather, we advise you immediately request the Manufacturer send the correct explanations or further details.
- The "Instruction Manual" must be accessible by authorised operators at all times and must be always be kept in a safe place within close proximity of the appliance.

ELECTRICAL MAINTENANCE



A gualified technician, capable of carrying out exclusive interventions on electrical devices in order to oversee the regulation, maintenance and/or repairs even where an electric supply is present and even with protective devices disabled in complete com-

pliance with the instructions presently provided or with any other specific document supplied by the Manufacturer, whilst using the dedicated personal safety device items.


A qualified technician offered by the Manufacturer and/or Supplier authorised to provide required technical assistance, standard and extraordinary maintenance interventions and/or operations which are not presently included which necessitate specialist

knowledge of the appliance, whilst using the dedicated personal safety device items.

7. STATUS "APPLIANCE OFF"

Before carrying out any type of maintenance and/or regulation operation on the appliance, you must:

- Shut off the power supply ensuring that the switch (1) is in the "OFF (0)" position.
- Unplug the power cable from the plug located near the appliance.
- Empty the tank (16) (no pressure).





8. GUARANTEE

- 1) GUARANTEE DECLARATION: the Manufacturer gives an undertaking to the End-User to replace, repair or otherwise intervene in the machine, if it has conformity defects that compromise its correct use and operation, but only if such defects are attributable to the actual liability of the Manufacturer. The Manufacturer reserves the right to adopt the optimal solution to restore the conformity of the machine within a reasonable period of time. The guarantee does not cover parts of the Products subject to normal wear and tear and/or deterioration or defects resulting from inappropriate transport.
- 2) END-USER: the End-User is the person who buys the machine to use it directly. The End-User who buys the machine as a natural person for purposes that do not fall within the scope of commercial or professional activity is defined as a "consumer". The End-User is defined as a "professional or company" when the purchase is made by a professional or by a company acting for purposes which fall within the scope of its commercial or professional activity.
- 3) **TERMINALS:** the Manufacturer is liable to the End-User when the lack of conformity occurs within the following terms from the date of purchase:

24 months if the purchase was made by a 'consumer' as described in point 2).

12 months if the purchase was made by a "professional or company" as described in point 2). All End-Users have the right to extend the guarantee (Extended Guarantee) for up to three years from the date of purchase of the machine if they: (a) have registered their purchase on the website www.gentilinair.com within seven days of purchase and (b) have completed the registration form completely and accurately, filling in the required fields with exact, complete and true information and have kept the registration code to be mentioned in the event of problems. Replaced parts or products will remain under guarantee until the original product guarantee expires.

- 4) VALIDITY: the guarantee is valid if the End-User notifies the Manufacturer of the conformity defect within 2 months from the date on which he has discovered it, but within the final term indicated in point 3) above. The above report must be accompanied by a regular purchase document (tax receipt or invoice). In the case of an Extended Guarantee, the declaration must also indicate the registration code.
- 5) FORFEIT: the guarantee will be void if the purchaser uses the machine improperly and/or not in accordance with the provisions of this "Instruction Manual" provided by the Manufacturer, or if the lack of conformity was caused by inexperience on the part of the purchaser or by chance. The use of the products after the discovery of defects releases the Manufacturer from any guarantee commitment or liability.
- 6) LIABILITY: the Manufacturer is released from any liability resulting from any damage sustained by the purchaser, resulting from loss or diminution of production which derives from any lack of conformity.
- 7) COSTS: the End-User has the right to the restoration of the conformity of the machine under guarantee without any costs for labour or materials. The shipping methods must be agreed with the authorised dealer or with the Manufacturer. In the event that the non-conformity is only apparent or the complaint arrives after the deadline, the Manufacturer may charge the cost of both transport and any repair that is indicated by the authorised dealer or the Manufacturer.

- No parts of the present manual, in full or in part, may be copied and/or passed on in any way, without written authorisation from the Manufacturer.

10. INTENDED USE

FIELD OF OPERATION

Industrial, handicraft and civil.

PLACE OF OPERATION

Interior locations with sufficient lighting, ventilation, with temperature and air humidity values as per details provided in Paragraph 2, in compliance with legislation governing health and safety in the work place in force in the country of usage. The appliance must rest on a surface that ensures the appliance is stable with respect to its weight and overall dimensions (see Paragraph 2).

WARNING!

THE APPLIANCE MUST BE KEPT OUT OF REACH OF CHILDREN.

INTENDED USE

Compressing air (no oil) to be used with suitable pneumatic utensils according to current legislation in force (E.g. blowing, pumping, washing, veneering and sandblasting, etc.).

OPERATORS AUTHORISED USE

An authorised operator with professional, technical skills as described in Paragraph 6.

11. INCORRECT USE

The appliance was designed and manufactured exclusively for the aim as described in Paragraph 10; in order to ensure the safety of authorised operators and appliance efficiency at all times, any other use is completely forbidden.



IT IS STRICTLY FORBIDDEN TO START THE MACHINE IN ANY ATEX ZONE, I.E. IN ENVIRONMENTS WITH A POTENTIALLY EXPLOSIVE ATMOSPHERE AND/OR CONTAINING COMBUSTIBLE DUSTS (E.G. WOOD DUSTS, FLOURS, SUGARS AND GRAINS).

IT IS ABSOLUTELY FORBIDDEN TO USE THE MACHINE IN AREAS CONTAINING SOLID OR ABRASIVE PARTICLES.



12. TRANSPORTATION AND MOVEMENT OF THE APPLIANCE

The machine can be manually carried by an operator using the handle (A) and the wheels (B).

TRANSPORTATION OF THE APPLIANCE MUST BE CARRIED OUT BY TWO QUALIFIED OPERATORS IN COMPLIANCE WITH REGULATIOSNS OVER-SEEING "MANUAL MOVEMENT OF LOADS" IN ORDER TO AVOID UNFAVOURA-BLE ERGONOMIC CONDITIONS WHICH COULD LEAD TO THE RISK OF BACK INJU-RIES.



13. PACKAGING

The machine is packed by the Manufacturer on a pallet, fixed with straps and covered by a cardboard box and can only be moved using a fork lift truck or a transpallet. The pack contains 1 compressor and 1 instructions manual.

14. UNPACKING

Once the package has been placed on the floor on a flat surface which ensures stability, proceed with unpacking; remove the appliance from its packaging as per the instructions provided in Paragraph 12.

15. LOCATION

The appliance must be placed in a work place which satisfies the characteristics described in Paragraph 10; it must be placed on a flat surface which ensures stability with regards to overall dimensions and weight (see Paragraph 2).



16. STORAGE

- · In the instance where the appliance is not to be used for an extended period of time, it must be stored in a safe place, with suitable temperature and air humidity values, where it is protected from dust.
- Before storing the appliance, we recommend draining moisture from the air tank and completely discharging the pressure in the tank.

17. ELECTRICAL CONNECTION

The machine can be connected to the mains electrical supply by plugging the power cable into the special socket **(13)**.



THE POWER SUPPLY NETWORK TO WHICH THE APPLIANCE IS CONNECTED MUST CONFORM TO THE LEGISLATION CURRENTLY IN FORCE IN THE COUNTRY OF USAGE, CONFORM TO THE TECHNICAL SPECIFICATIONS PRO-VIDED IN PARAGRAPH 2 AND BE EQUIPPED WITH A SUITABLE "PLANT EARTHING" SYSTEM.

ALL MATERIALS USED FOR ELECTRICAL CONNECTION MUST BE SUITED TO THE INTENDED USAGE, LABELLED WITH "CE" IF SUBJECT TO THE LOW VOLTAGE DI-RECTIVE 2006/95/CE AND CONFORM TO THE REQUIREMENTS AS SPECIFIED IN THE LEGISLATION CURRENTLY IN FORCE IN THE COUNTRY OF APPLIANCE USA-GE.

DISREGARD FOR THE ABOVE DESCRIBEDWARNINGS MAY LEAD TO IRREPERABLE DAMAGE TO THE APPLIANCE ELECTRICAL SYSTEM AND SUBSEQUENTLY WAR-RANTY EXPIRY.

THE MANUFACTURER DECLINES ANY RESPONSIBILITY FOR FAULTS OR ANOMOLIES WITH APPLIANCE OPERATION CAUSED BY ELECTRICAL POWER SURGES IN ADDITION TO TOLERANCES BY THE SUPPLY ENTITY (VOLTAGE \pm 10%, FREQUENCY \pm 2%).

WHERE NECESSARY, CONNECT THE APPLIANCE EXCLUSIVELY TO THE ELECTRI-CAL SUPPLY GENERATOR WITH POWER GRTEATER THAN THE INSTALLED ELEC-TRICAL POWER (SEE PARAGRAPH 2), IN ORDER TO SUPPORT THE POWER-DRA-WAT START-UP.

IT IS STRICTLY FORBIDDEN TO START THE MACHINE IN ANY ATEX ZONE, I.E. IN ENVIRONMENTS WITH A POTENTIALLY EXPLOSIVE ATMOSPHERE AND/OR CONTAINING COMBUSTIBLE DUSTS (E.G. WOOD DUSTS, FLOURS, SUGARS AND GRAINS).

THE MACHINE MUST BE ELECTRICALLY CONNECTED TO THE MAINS LINE UN-DER THE SOLE RESPONSIBILITY OF THE CUSTOMER, USING SKILLED PERSONNEL AND IN COMPLIANCE WITH EN 60204.

EARTHING INSTRUCTIONS

- This compressor must be earthed while in use to protect the operator from electric shocks.
- It must be electrically connected by an electrician.
- · Never disassemble the compressor or make any other connections.
- Any repairs must only be carried out by authorised service centres or by other qualified centres.
- The earth wire of the power cable supplied with the compressor must only be connected to the PE terminal of the compressor's plug.
- Before replacing the plug on the power cable, make sure that the earth wire is connected.

EXTENSION LEAD

- Only use an extension lead with a plug and earth connection, do not use damaged or crushed extension leads.
- Make sure that the extension lead is in good condition.
- When using an extension lead, ensure that the cable cross-section is enough to carry the current absorbed by the product to be connected.
- An extension lead that is too thin can cause voltage drops resulting in a loss of power and overheating of the equipment.
- The extension lead of a three-phase compressor must have a cross-section proportionate to its length: see table below.

AVOID ALL RISKS OF ELECTRIC SHOCK.

ELECTRICAL CONNECTION

- SINGLE-PHASE compressors (1 ph) must be installed by a skilled technician. Singlephase compressors are supplied with a power cable without a 16A 6h "CE" certified plug.
- **THREE-PHASE compressors (3 ph)** version L1+L2+L3+N+PE 380÷415V and version L1+L2+L3+PE 220÷240V) must be installed by a skilled technician. Three-phase compressors are supplied with a cable without a plug.
- It is advisable to install the circuit breaker and fuses near (max 3 m away) to the compressor. The circuit breaker and fuses must have the characteristics given in the following table:

kW/HP power	Rated voltage	Circuit breaker	Fuse
0/4 D: 1	220/240V 1 ph	25 A	32 A
3/4 Direct roll-up (D.O.L.)	220/240V 3 ph	16 A	20 A
(0.0.2.)	380/415V 3 ph	10 A	16 A

The values of the fuses in the table above refer to gL (standard) ones; If aM (delayed) fuse cartridges are used, the values in the table must be reduced by 20%.

The values of the circuit breakers refer to switches with K characteristic.

- Check that the kW installed power is at least double the power consumption of the electric motor.
- The mains voltage must be the same as that indicated on the machine's electrical data plate; the permissible tolerance range must be within ±6%. EXAMPLE:230 Volt: MIN tolerated 216 Volt - MAX tolerated 244 Volt 400 Volt: MIN tolerated 376 Volt - MAX tolerated 424 Volt

400 VOIT: MIN TOIERATED 376 VOIT - MAX TOIERATED 424 VOIT

• The plug of the power cable must not be used as a switch, but it must be plugged into a socket controlled by an appropriate RCD (circuit breaker).



NEVER USE THE EARTH SOCKET INSTEAD OF THE NEUTRAL. THE EARTH CONNECTION MUST BE DONE ACCORDING TO EN 60204.

CHECK THAT THE MAINS VOLTAGE IS THE SAME AS THE ONE REQUIRED FOR CORRECT OPERATION OF THE COMPRESSOR.


GENERAL OPERATING INFORMATION

- The compressor is only used to power/operate pneumatic tools.
- The pumping unit is operated by an electric motor flanged to the motor which ensures a constant pressure in the tank, keeping it between the minimum and maximum calibration limit regulated by the Pilot Valve (default pressures) (see Fig. 1: pilot valve).

WARNING: IF THERE IS A POWER FAILURE DURING OPERATION, BEFORE RE-STARTING THE COMPRESSOR, TURN THE POWER SWITCH ON THE PRES-SURE SWITCH (1) TO "OFF" AND WAIT FOR THE AIR IN THE STORAGE TANK TO BE FULLY DISCHARGED (PRESSURE GAUGE (15) ON ZERO, THEN RESTART THE COMPRESSOR BY TURNING THE POWER SWITCH (1) TO "ON".



19. SAFETY DEVICES ADOPTED

SAFETY VALVE (10): a certified safety valve (set to 10.5 bar), installed to the pneumatic system, under the pressure switch. It tackles over-pressure in the instance where, owing to anomalies, the pressure switch does not function. Safety valve intervention ensures the operator switches off the appliance and requests the support of maintenance persons.


PRESSURE SWITCH (2): an electro-pneumatic device (set to a minimum of 7 bar and a maximum of 10 bar) installed to the pneumatic system. It serves to control the automatic start-up of the appliance when the operating pressure comes down to 7 bar and the automatic close-down when the pressure reaches 10 bar.


FAN COVER (19): fixed protection made of plastic attached using screws fixed to the twin cylinder pump system base. It serves to stop accidental contact with the cooling fan when in motion.

TANK PRESSURE GAUGE (15): a measuring device installed to the appliance tank. It displays the compressed air pressure inside the tank.

OUTLET PRESSURE GAUGE (8): a measuring device installed to the appliance pneumatic system above the air outlet spigot.

It displays the outlet pressure, which can be adjusted using the relative pressure regulator $(0\div10 \text{ bar})$ (7).




25. PRE-START-UP CHECKS


27. APPLIANCE DEACTIVATION

- Disconnect the appliance from the power supply (1) by unplugging it.

- Disconnect the air pipe (extension) from the appliance air outlet spigot (5).
- Drain the moisture from the tank only at the end of operations and ensure that the residual pressure in the tank is completely discharged **(A)**.









28. VOLTAGE OVERLOAD SAFETY RESET

In the instance where current overload and/or a short circuit of the appliance electrical system is noted, a safety devicerestore intervenes, disabling the electric motor. **To carry out the reset intervention, proceed as follows:**

- Turn the switch (3) to the "OFF (0)" position.
- Wait a few minutes, then turn on the machine again.


